The Capillary tube thermostat type EL-CT and EL-CT (2) is provided for the connection of a heating conductor in potentially explosive atmospheres.

It consists of a flameproof enclosure with built in thermostat and capillary tube bushing.

*Summary of the test results*

The capillary tube thermostat type EL-CT and EL-CT (2) meets the requirements of explosion protection for devices of group II, category 2G in type of protection flameproof enclosure "d" and category 2D in type of protection protection by housing "tb".

[17] **Specific conditions of use**

When selecting the cable glands as well as the connection cable, the corresponding requirements of IEC 60079-14, section 10.6.2 must be observed.

Only temperature-resistant cables, which are suitable for a temperature of at least 90 °C, may be used at the Capillary tube thermostat types EL-CT and EL-CT (2).

The cable entry supplied by the manufacturer may be used only for fixed installation. The operating company has to ensure an appropriate clamping.
